 - o effectiveness evaluation;
 - impact evaluation; and
 - o maintenance evaluation.
- Outline an evaluation plan for various forms of e-learning.
- Recognize the advantages and limitations of e-learning evaluation.

About the facilitators

Dr. Thomas C. Reeves is Professor Emeritus of Learning, Design, and Technology at The University of Georgia. In addition to numerous presentations and workshops in the USA, he has been an invited speaker in 29 other countries including serving as a previous keynote speaker at ASCILITE. In 1995, he was selected as one of the "Top 100" people in multimedia by *Multimedia Producer* magazine, and from 1997 - 2000, he was the editor of the *Journal of Interactive Learning Research*. In 2003, he was the first person to receive the AACE Fellowship Award from the Association for the Advancement of Computing in Education. He co-authored *Interactive Learning Systems Evaluation* with Professor John Hedberg in 2003, and he co-authored *A Guide to Authentic E-learning* with Professor Jan Herrington and Professor Ron Oliver in 2010.
